### BYLAW NO. 1612, 2020

#### **A bylaw to amend the Building Numbering Conversion and Extended Service Area Establishment Bylaw**

---

**WHEREAS** the *Fraser Valley Regional District Building Numbering Conversion and Extended Service Area Establishment Bylaw No. 0080, 1996* was adopted by the Fraser Valley Regional District Board of Directors ("the Board") on April 22, 1997;

**AND WHEREAS** the Board deems it necessary to amend Bylaw No. 0080, 1996 as amended, to recognize the division of the former Electoral Area E of the Fraser Valley Regional District into Electoral Areas E and H in accordance with Order in Council No. 501, approved and ordered on September 5, 2014 and Letters Patent effective December 17, 2014 issued by the Province of British Columbia;

**AND WHEREAS** consent on behalf of the electoral participating areas of the Fraser Valley Regional District has been obtained in accordance with the *Local Government Act*;

**THEREFORE** the Board of Directors of the Fraser Valley Regional District enacts as follows:

#### **1) CITATION**

This bylaw may be cited as the *Fraser Valley Regional District Building Numbering Service Area Amendment Bylaw No. 1612, 2020*.

#### **2) ENACTMENTS**

That Fraser Valley Regional District Bylaw No. 0080, 1996 be amended by:

- a. Deleting Section 2c and replacing it with the following:  
"The boundaries of the Fraser Valley Regional District Building Numbering Service Area shall be all of Electoral Areas A, B, C, D, E, F, G and H, except those portions of Electoral Area H which are separately administered by the Cultus Lake Park Board.
- b. Deleting Section 2d and replacing it with the following:  
"The participating areas of the Fraser Valley Regional District Building Numbering Service Area shall be Electoral Areas A, B, C, D, E, F, G and H of the Fraser Valley Regional District."

#### **3) SEVERABILITY**

If a portion of this bylaw is found invalid by a court, it will be severed and the remainder of the bylaw will remain in effect.
