

**FRASER VALLEY REGIONAL DISTRICT  
BYLAW NO. 1605, 2020**

**A bylaw to amend the DARD Community Parks Service Area**

---

**WHEREAS** the Fraser Valley Regional District Board of Directors ("the Board") wishes to amend the boundary of the Service Area established by *Dewdney-Alouette Regional District Local Service Community Parks Establishment Bylaw No. 647-1993, as amended, to exclude all portions of Electoral Area C;*

**AND WHEREAS** consent on behalf of the electoral participating areas has been obtained;

**THEREFORE** the Board enacts as follows:

**1) CITATION**

This bylaw may be cited as *Fraser Valley Regional District Electoral Area F & G (DARD) Community Parks Service Area Amendment Bylaw No. 1605, 2020.*

**2) ENACTMENTS**

*Dewdney-Alouette Regional District Local Service Community Parks Establishment Bylaw No. 647-1993* is hereby amended by:

- a) Deleting Section 1 in its entirety and replacing it with the following: "The service being established under this bylaw is a service for community parks to be known as "the Electoral Area F & G Community Parks Service Area."";
- b) Deleting Section 2 in its entirety and replacing it with the following: "The boundaries of the service established by this bylaw are the boundaries of Electoral Areas F and those portions of Electoral Area G of the Fraser Valley Regional District as shown on Schedule 1605-A, attached hereto and forming an integral part of this bylaw.";
- c) Deleting Section 3 in its entirety and replacing it with the following: "The participating areas for the service established by this bylaw shall be Electoral Areas F and G of the Fraser Valley Regional District.";
- d) Deleting Section 4(a) in its entirety and replacing it with the following:
  - "4. a) The annual costs for the service established by this bylaw shall be recovered by one or more of the following:
    - i. The requisition of money to be collected by a property value tax;
    - ii. The imposition of fees and other charges that may be fixed by separate bylaw for the purpose of recovering these costs; and/or

- iii. Revenues received by way of agreement, enterprise, gift, grant or otherwise.”
- e) Deleting, in Section 4, the entire clause added by *Fraser Valley Regional District Community Parks Service Area Amendment Bylaw No. 0541, 2002* relating to apportionment of costs. For greater clarity, the costs will be apportioned equally between the participants.
- f) That the provisions of all bylaws that are now in effect with regard to the establishment and amendment of the Electoral Areas F & G Community Parks Service Area remain in full force and effect.

### 3) **SEVERABILITY**

If a portion of this bylaw is found invalid by a court, it will be severed and the remainder of the bylaw will remain in effect.

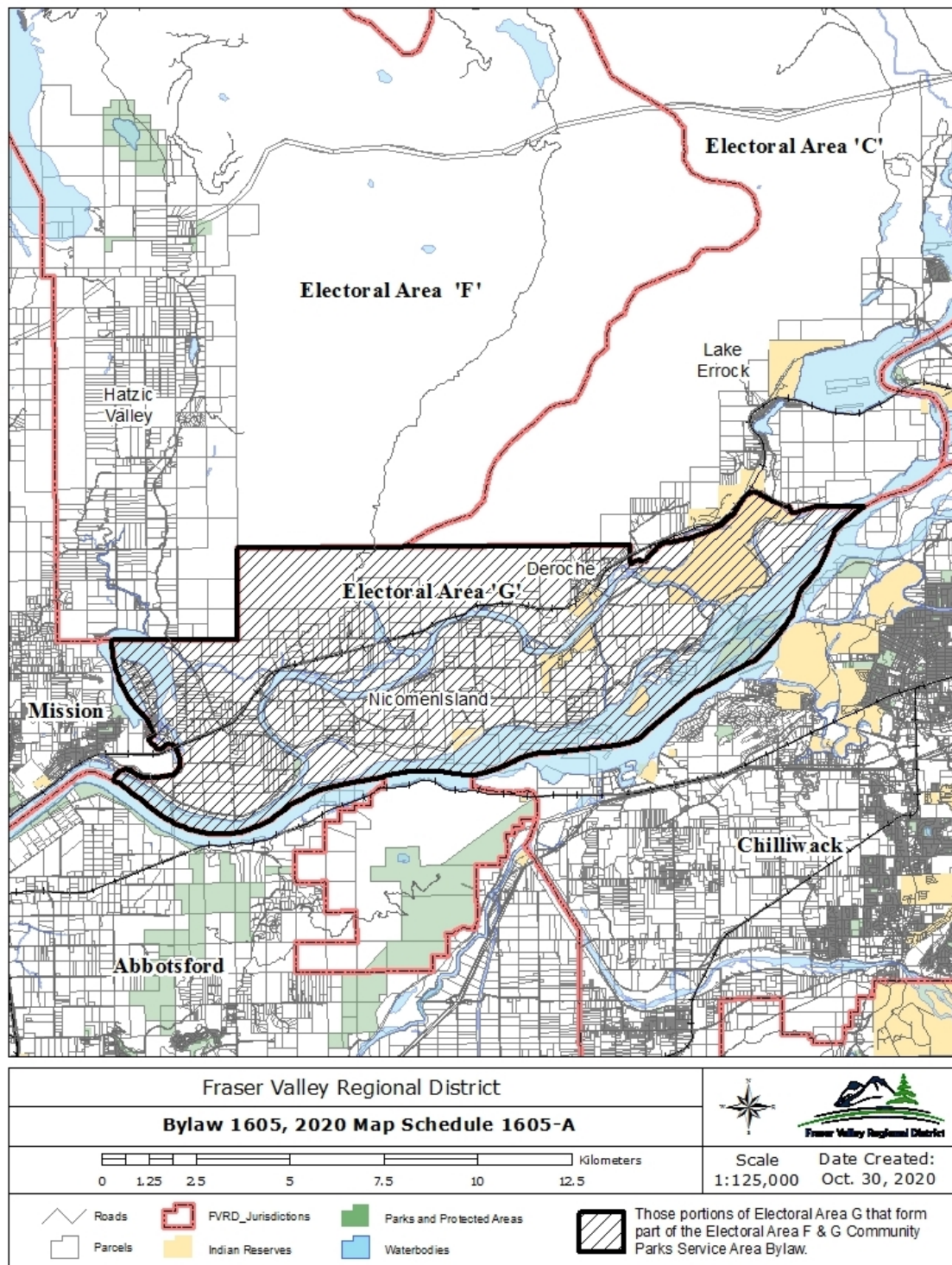
