

**FRASER VALLEY REGIONAL DISTRICT  
BYLAW NO. 1595, 2020**

**A bylaw to convert the Dewdney Alouette Regional District garbage disposal function to a Service Area and to amend the boundaries of the Service Area.**

---

**WHEREAS** the Dewdney Alouette Regional District ("DARD") was granted the function of garbage disposal through Supplementary Letters Patent dated October 9, 1975 with the participants being DARD Electoral Areas B, C, D and E.

**AND WHEREAS** the current corresponding participating Electoral Areas of the Fraser Valley Regional District for the service are portions of Electoral Areas C, F and G;

**AND WHEREAS** in accordance with S. 341 of the *Local Government Act* the Fraser Valley Regional District Board of Directors ("the Board") wishes to convert the DARD garbage disposal function as granted by Supplementary Letters Patent to a Service Area;

**AND WHEREAS** the Board also wishes to amend the service area to exclude all portions of Electoral Area C, for the purpose of including those portions in the service area proposed by *Fraser Valley Regional District Electoral Area C Garbage Disposal Service Area Amendment Bylaw No. 1596, 2020*;

**AND WHEREAS** the Board also wishes to amend the service area to include further portions of Electoral Area F;

**AND WHEREAS** consent of at least 2/3 of the participants has been obtained in accordance with the *Local Government Act*;

**THEREFORE** the Board enacts as follows:

**1) CITATION**

This bylaw may be cited as *Fraser Valley Regional District Electoral Areas F and G Garbage Disposal Service Area Conversion and Amendment Bylaw No. 1595, 2020*.

**2) ENACTMENTS**

- a) The Dewdney Alouette Regional District garbage disposal function granted through Supplementary Letters Patent dated October 9, 1975 is hereby converted to and established as a service area to be known hereafter as the "Electoral Areas F and G Garbage Disposal Service Area";
- b) The participating areas for the service established by this bylaw shall be Electoral Areas F and G of the Fraser Valley Regional District.
- c) The boundaries of the service area established by this bylaw shall be:

- i. those portions of Electoral F of the Fraser Valley Regional District as shown on Schedule 1595-A attached to and forming an integral part of this bylaw; and
  - ii. those portions of Electoral Area G of the Fraser Valley Regional District as shown on Schedule 1595-B, attached to and forming an integral part of this bylaw.
- d) The annual costs for the service established by this bylaw shall be recovered by one or more of the following:
  - i. The requisition of money to be collected by a property value tax;
  - ii. The imposition of fees and other charges that may be fixed by separate bylaw for the purpose of recovering these costs; and/or
  - iii. Revenues received by way of agreement, enterprise, gift, grant or otherwise.
- e) The maximum amount that may be requisitioned annually for the service established by this bylaw shall be an amount equal to that which could be raised by a property value tax rate of \$2/\$1000 applied to the net taxable value of the land and improvements within the service area.

### 3) SEVERABILITY

If a portion of this bylaw is found invalid by a court, it will be severed and the remainder of the bylaw will remain in effect.

#### 4) READINGS AND ADOPTION

READ A FIRST TIME this 24<sup>th</sup> day of November, 2020

READ A SECOND TIME this 24<sup>th</sup> day of November, 2020

READ A THIRD TIME this 24<sup>th</sup> day of November, 2020





