FRASER VALLEY REGIONAL DISTRICT BYLAW NO. 1596, 2020

A bylaw to amend the boundaries of the Harrison Mills and Vicinity Garbage Collection and Disposal Local Service Area to include all of Electoral Area C and to rename the service area

WHEREAS the Fraser Valley Regional District Board of Directors ("the Board") wishes to amend the boundary of the Service Area established by *Fraser Valley Regional District Harrison Mills and Vicinity Garbage Collection and Disposal Local Service Area Conversion Bylaw No. 0208, 1997 to include all of <i>Electoral Area C*;

AND WHEREAS consent on behalf of the electoral participating areas of the Fraser Valley Regional District has been obtained;

THEREFORE the Board enacts as follows:

1) CITATION

This bylaw may be cited as Fraser Valley Regional District Electoral Area C Garbage Disposal Service Area Amendment Bylaw No. 1596, 2020.

2) **ENACTMENTS**

Fraser Valley Regional District Fraser Valley Regional District Harrison Mills and Vicinity Garbage Collection and Disposal Local Service Area Conversion Bylaw No. 0208, 1997, as amended, is hereby amended by:

- a) Extending the boundaries of the Service Area to include Electoral Area C in its entirety;
- b) Deleting Section 2.b) in its entirety and replacing it with the following:
 - "2. b) The service area established shall be known as the "Electoral Area C Garbage Disposal Service Area (the "Service Area");
- c) Deleting Section 2.c) in its entirety and replacing it with the following:
 - "2.c) The participating area and boundaries for the service established shall be all of Electoral Area C of the Fraser Valley Regional District.";
- d) Deleting Section 2.d) in its entirety and replacing it with the following:
- "2. d) The annual costs for the service established by this bylaw shall be recovered by one or more of the following:
 - i. The requisition of money to be collected by a property value tax;

- ii. The imposition of fees and other charges that may be fixed by separate bylaw for the purpose of recovering these costs.
- e) Deleting all Map Schedules attached to the bylaw;
- f) That the provisions of all bylaws that are now in effect with regard to the establishment and amendment of the Electoral Area C Garbage Disposal Service Area (Harrison Mills and Vicinity Garbage Collection and Disposal Local Service Area) remain in full force and effect.

3) **SEVERABILITY**

If a portion of this bylaw is found invalid by a court, it will be severed and the remainder of the bylaw will remain in effect.
