#### 7. DELEGATIONS AND PRESENTATIONS

### 7.1 <u>Mike Thomas and Kerri-Ann Thomas, Tanex Consulting</u>

Mike Thomas and Kerri-Ann Thomas from Tanex Consulting gave a joint presentation, providing a brief overview of their company background and objectives. They spoke to broadband basics, process for addressing connectivity in rural and remote areas, deliverables, funding opportunities/criteria and the need for broadband, noting that not having reliable connectivity is a disadvantage to residents/businesses. They also presented on the 'Service Delivery Pyramid' to solve connectivity problem.

Questions were raised regarding the viability of the project, return on investment and the challenges of internet connectivity in rural areas.

#### 11.6 <u>2020-2024 Electoral Area Wide Services – DRAFT Financial Plan</u>

Mike Veenbaas, Director of Financial Services provided a presentation on the *Draft 2020-2024 Financial Plan for Electoral Area-Wide Services*, covering the following:

- Electoral Area Administration
  - cost drivers: inflationary adjustments, 2019 EA Director remuneration change, previous corporate restructures, Engineering Coordinator reallocation;
- Fraser Valley Regional Library
  - increased funding for materials reserve, materials purchased, central library support;
- Electoral Area Utility Management
  - decreased recovery Engineering Services Coordinator reallocation
- Emergency Management
  - Emergency Program Training and Supplies and Emergency Program Assistant (tied to the recent Auditor-General of Local Government Audit on Emergency Management)
- Animal Control
- Building Inspection
  - anticipated leveling off of building permit revenues
  - proposal to return to a permanent Manager position
- Bylaw Enforcement
- Electoral Area Planning
  - funding for increasing public and community meetings
- Electoral Area Soil Removal
  - fully funded by soil removal user fees

Mr. Veenbaas further presented on the proposed Procurement and Risk Specialist position, outlining the funding allocation for this position.

The Committee offered comments and Staff provided clarification to questions raised from the Committee.

#### 13. PLANNING, BUILDING INSPECTION AND BYLAW ENFORCEMENT

#### 13.1 Development Application Fees Bylaw Update

Robin Beukens, Planner I provided a PowerPoint presentation with respect to the proposed Development Application Fees Bylaw, highlighting the following:

- legislative basis for local governments in BC to impose fees and charges for development applications
- process for determining new fees
- cost recovery aim for full cost recovery on applications that are primarily in the private interest of the applicant
- proposed new fees are moderate; significant increases for Development Variance Permits and Site Specific Exemptions
- DVP fee comparisons between member municipalities

**THAT** the Fraser Valley Regional District Board consider giving three readings and adoption to the bylaw cited as the "Fraser Valley Regional District Development Application Fees Bylaw No. 1560, 2019".

# 13.3 <u>The Use of Land for Processing Aggregates in FVRD's Electoral Area Zoning Bylaws</u>

Moved By RAYMOND Seconded By ENGAR **THAT** the Fraser Valley Regional District Board direct staff to provide information and assistance to the BC Stone, Sand & Gravel Association and individual gravel operators so that they can apply for zoning amendments or temporary use permits to allow gravel processing at mine sites;

**AND THAT** the Fraser Valley Regional District Board express its preference to consider zoning amendment applications to allow gravel processing after the results of independent monitoring of noise and dust emissions associated with gravel operations in priority areas is available so that baseline data about community impacts may be considered in conjunction with any applications submitted;

**AND FURTHER THAT** staff be directed to prepare, for consideration by the FVRD Board, a policy to: 1) focus Soil Removal service resources on implementation of *FVRD Commercial Gravel Operations Bylaw No. 1181*; and, 2) not enforce zoning provisions related to processing at existing mines if the mine is in compliance with *Bylaw No. 1181*.

Discussion ensued, resulting in the following motion:

**THAT** the Motion on the table be withdrawn.

### All Directors except Adamson, Bales and Davidson Opposed

Discussion ensued, emphasizing the role played by the Province in permitting, resulting in the following amendment:

Moved By RAYMOND Seconded By ENGAR

**THAT** the main motion be amended by removing the first paragraph of the motion which states "THAT the Fraser Valley Regional District Board direct staff to provide information and assistance to the BC Stone, Sand & Gravel Association and individual gravel operators so that they can apply for zoning amendments or temporary use permits to allow gravel processing at mine sites"; and adding the following wording:

**AND FURTHER THAT** the FVRD Board direct staff to contact the Ministry of Mines to present to the Board as to why they are not enforcing their permits when they are in contravention of the zoning bylaw.

CARRIED Directors Adamson, Bales and Davidson Opposed

Further discussion ensued, resulting in a motion regarding postponement as follows:

Moved By ADAMSON Seconded By DAVIDSON

**THAT** item 13.3 with respect to 'The Use of Land for Processing Aggregates in FVRD's Electoral Area Zoning Bylaws' be postponed to the February 2020 meeting of the Electoral Area Services Committee.

DEFEATED

All Directors except Directors Adamson, Bales, Davidson, Raymond Opposed

It was noted that a blanket zoning policy for all gravel pits is not feasible for the electoral areas, resulting in the following amendment:

Moved By DAVIDSON Seconded By BALES

**THAT** the main motion be amended by adding the following words to the end of the second paragraph of the main motion "for all Electoral Areas except for Electoral Areas C and F"

DEFEATED
All Directors except Directors Bales Opposed

Further discussion ensued and it was noted that having data to justify enforcement was relevant, resulting in the following amendment:

Moved By ENGAR Seconded By STOBBART **THAT** the main motion be amended by adding the following words to the end of the second paragraph of the main motion "while gathering data".

# DEFEATED Directors Adamson, Bales, Davidson and Raymond Opposed

Further discussion continued, resulting in the following amendment being put forward:

Moved by RAYMOND Seconded by DAVIDSON

**THAT** the following words be removed from the second paragraph "2) not enforce zoning provisions related to processing at existing mines if the mine is in compliance with Bylaw No. 1181."

CARRIED

The question was called on the main motion as amended:

Moved by ENGAR Seconded by DIXON

**THAT** the Fraser Valley Regional District Board express its preference to consider zoning amendment applications to allow gravel processing after the results of independent monitoring of noise and dust emissions associated with gravel operations in priority areas is available so that baseline data about community impacts may be considered in conjunction with any applications submitted;

**AND THAT** staff be directed to prepare, for consideration by the FVRD Board, a policy to 1) focus Soil Removal service resources on implementation of FVRD Commercial Gravel Operations Bylaw No. 1181;

**AND FURTHER THAT** the FVRD Board direct staff to contact the Ministry of Mines to present to the Board as to why they are not enforcing their permits when they are in contravention of the zoning bylaw.
