Further to our previous correspondence dated November 2, 2023 that was sent to you on the same day, please be advised you are hereby notified that your opportunity to be heard by the <u>Regional District Electoral Area Services Committee</u> is scheduled. The meeting is to **show cause** why the Regional District Board of Directors should not direct staff to file a Notice against the title of your property at 3640 Vance Road in relation to the outstanding contraventions of the *Fraser Valley Regional District Building Bylaw No. 1133, 2018"* and *BC Building Code* pursuant to Section 57 of the *Community Charter*.

The show cause hearing is scheduled for **Thursday April 11, 2024 at 1:30pm** in the Boardroom on the fourth floor of the Regional District Office at 45950 Cheam Avenue, Chilliwack, British Columbia. The meeting will also be held **by Zoom online video conference**.
