Amendment Bylaw No. 1719, 2023

RECOMMENDATION

THAT the Fraser Valley Regional District Board give first, second, and third readings to the bylaw cited as *Fraser Valley Regional District North Cultus Lake Sewer System Service Area Amendment Bylaw No.* 1719, 2023.

BACKGROUND

The proposed service area amendment bylaw would adjust the boundaries of the North Cultus Lake Sewer Service Area to include the Department of Fisheries and Oceans Canada (DFO) property located at 4222 Columbia Valley Road. The federally owned property currently houses the Cultus Lake Salmon Research Facility and contains several laboratories, artificial streams and ponds, and an experimental hatchery. The site is home to 11 full time DFO employees, and is utilized by numerous other DFO staff, graduate students and university researchers, and guests.

DISCUSSION

The property currently relies on an individual septic system and an onsite absorption field for wastewater disposal. DFO, as well as the Cultus Lake Park Board, are interested in redirecting sanitary discharge from the aging onsite septic system to the FVRD's system for treatment and disposal. As part of the inclusion into the service area, DFO will be responsible for the construction of additional sanitary infrastructure from the connection point of the Cultus Lake Laboratory property to the FVRD pump station SL#4. The construction of the sewer infrastructure will allow for additional Cultus Lake Park Board properties to be included and connected to the sewer service area in the future.

The property in question is on Federal Crown land and will be unable to meet the legislative requirements for a petition into the service area. However, pursuant to the *Local Government Act*, written consent from the Electoral Area H Director for the adoption of the service area bylaw amendment may be provided instead. After receiving three readings, the bylaw requires approval by

the Inspector of Municipalities. Once the bylaw has received this approval it will be brought back to the FVRD board for adoption.

The FVRD is in receipt of a signed Servicing Agreement which covenants that the DFO will design and construct all infrastructure works associated with the connection of the DFO property to the FVRD sanitary sewer system. Included within the Servicing Agreement is a capital connection improvement fee of \$13,549.75 to join the service area, as well a provision that notes service cannot be guaranteed until the new North Cultus Wastewater Treatment Plant is operational. This agreement will also act as the written request from the DFO to include their property located at 4222 Columbia Valley Road into the North Cultus Lake Sewer Service Area.

COST

No costs to the FVRD.

All associated sewer infrastructure upgrades and costs will be borne by His Majesty King in Right of Canada as represented by the Ministry of Fisheries and Oceans Canada.

BYLAW NO. 1719, 2023

A bylaw to amend the boundaries of the North Cultus Sewer System Service Area

WHEREAS the Fraser Valley Regional District Board of Directors ("the Board") has been petitioned to amend and extend the boundary of the North Cultus Lake Sewer System Service Area established by *Regional District of Fraser Cheam Cultus Bylaw No. 875, 1989,*

AND WHEREAS BC Reg 113/2007 exempts service area boundary amendments from inspector approval where valid and sufficient petitions are submitted by the owners of the parcels to be added or removed:

THEREFORE the Board enacts as follows:

1) CITATION

This bylaw may be cited as *Fraser Valley Regional District North Cultus Lake Sewer System Service Area Amendment Bylaw No. 1719, 2023.*

2) **ENACTMENTS**

- a) Regional District of Fraser Cheam Cultus Lake Park Collector Sewer System Local Service Area Establishment Bylaw No. 875, 1989 is hereby amended as follows:
 - i. By extending the boundaries of the Service Area to include the properties shown on Schedule 1719-A attached to and forming an integral part of this bylaw.
 - ii. By deleting Schedule A to Bylaw No. 875, 1989 and replacing it with Schedule 1719-B, attached to and forming an integral part of this bylaw. The amended boundaries of the service area shall be those portions of Electoral Area H as shown on Schedule 1719-B.
- b) The provisions of all bylaws that are now in effect with regard to the establishment and amendment of the North Cultus Lake Sewer System Service Area shall henceforth apply to those lands outlined on Schedule 1719 B of this bylaw.

3) SEVERABILITY

If a portion of this bylaw is found invalid by a court, it will be severed and the remainder of the bylaw will remain in effect.




