RECOMMENDATION

BACKGROUND

The Emergency Management Executive Committee (EMEC) plays a critical role in ensuring the success of the Fraser Valley Regional District's Emergency Management Program. As outlined in Bylaw No. 1622, 2021, the EMEC is responsible for:


- 1. **Strategic Oversight** Providing direction and organizational support for the Emergency Management Program.
- 2. **Performance Evaluation** Assessing the program's effectiveness in alignment with Board policies and legislative requirements.
- 3. **Recommendations & Advice** Offering guidance to the Board and Director of Emergency Management on program improvements.
- 4. **Integration & Preparedness** Ensuring FVRD departments, staff, and volunteers are effectively engaged and ready for emergencies.
- 5. **Interdepartmental Coordination** Leading initiatives and projects that intersect with emergency management.
- 6. **Policy & Plan Review** Providing preliminary approval of emergency management plans and policies before they proceed to the Board.

This serves as a reference to help the EMEC fulfill its mandate effectively. The focus of this report is to highlight the achievements of our departmental efforts to implement the Emergency Management Program Policy.

DISCUSSION

FVRD's emergency management program has been guided by the Emergency Management Program Policy ("the Program") since it was approved by the Board in 2023. The program outlines the structure of the program within the organization, how each business remains distinct and yet is inherently linked under the broader umbrella of the Emergency Management Program. Staff in the emergency management department manage the program, however, program linkages in other business units still remain with the oversight of its leadership. As such, the emergency management program policy establishes core components of the program that can be managed by the staff in the emergency management department. Some aspects necessary for FVRD to achieve EDMA compliance remain outside the scope of the emergency management staff oversight.

The core components of the FVRD Emergency Management Program that are managed by the EM department are:
