Application Summary Project or purpose for which you require assistance:

Cultus Lake Day is a free-to-attend annual community event open to the public that relies solely on funding from grants, sponsorship and donations made to the volunteer committee to be able to deliver this memorable event. It is set to be held on June 21, 2025, and includes a range of all-ages activities including a parade, a pancake breakfast (managed by the Cultus Lake Volunteer Fire Department), a children's fun zone including bouncy castles, face painting, rides on the Rotary train, and an obstacle course, live music from local artists, a vendor market with local artisans, and food trucks. An estimated 10,000 people have attended this highly popular event each year over the last several years and it provides the opportunity for residents of Cultus Lake Park and visitors from across the Fraser Valley to kick off summer and enjoy family-friendly fun at Main Beach.

Statement as to how these funds will benefit the community:

Cultus Lake Day is a family-friendly community event that helps to build strong relationships among the residents of Cultus Lake Park and the greater community of the FVRD. This grant will benefit the FVRD community as a whole by providing the opportunity for people to spend quality time together with their family and friends - new and old, in a fun, lively and safe environment surrounded by the beauty of Cultus Lake Park.

*Another popular event hosted by the Cultus Lake Park Board Community Events and Engagement Committee is Cultus Lake Christmas to be held on or about November 22, 2025, and provides families an opportunity to bring their children (or fur babies!) to have photos with Santa, a vendor market, a marshmallow roast, hot chocolate stand, food trucks and a fireworks display. This event is also open to the public, attended by over 5,000 people each year over the last several years, is free to attend and also relies solely on funding from grants, sponsors and donations for the volunteer committee members to be able to deliver another memorable event. Should the application be approved, any and all funds would be used entirely for one or both of these community events.
