Thanks for your patience. I wanted to do my due diligence before responding. With regard to a telecommunications tower and associated access road you can proceed without notifying ALC in the future as it is federally regulated. However, if there is other infrastructure associated with the telecommunications tour (for example a formal road dedication) or the tower requires subdivision, or any other additional infrastructure request/property change outside of the tower + access, you should check with the ALC before proceeding.

I hope this clarifies things and again sorry for the slow reply.
