### 10. REPORTS BY ELECTORAL AREA DIRECTORS

<u>Director Johnson</u>: Attended "Building Resilient Communities" workshop in Hope.

<u>Director Waardenburg:</u> Attended the Lions Fundraiser at the Deroche Hall, the ACES seed exchange in Area G, and a Bingo Fundraiser at the Harrison Mills Hall.

<u>Director Dixon:</u> Attended the clean up on Soowahlie land with many volunteers. Concerns are rising around homelessness in Area H, including theft and damages to property and land. Delivered FireSmart flyers to the community and began cleaning up debris in area to ensure fire safety. Road work and the Blue Creek project continue to take place. Summer planning meeting to take place with the RCMP and Cultus Lake Park Board and invitation to all to attend the Easter Egg Hunt at 11am on Saturday, April 12.

<u>Director MacAhonic:</u> Attended the Vedder River clean up with 114 volunteers and working on scheduling another stakeholder meeting. Various concerns in Electoral Area E: safety of residents, theft, trespassing, damages to land, and noted that a meeting will be taking place with the Acting Superintendent of the RCMP. There are now 7 homeless camps in the area. Emergency Management team will be presenting on evacuation plan and FireSmart.

<u>Director Cassel:</u> Noted that the Sasquatch Lions raised over \$17,000 during their garage sale and auction and additional money was raised by the North Fraser Fire Department volunteers through a pancake breakfast. Attended a meeting with Fraser Nicola MLA Luck, along with Directors Davidson and Waardenburg and discussed a range of topics. Director Cassel noted that Leq'a:mel First Nation held their elections for Chief and Council and extended congratulations to the new Chief, Stacey Goulding.

<u>Director Adamo:</u> Presented to the Royal Canadian Legion Executive, Branch 228 in Hope, in search of a new recruit to participate in housing initiative. Participated in a driving tour with a local realtor to identify some potential development opportunities. Met with investment group from Alberta and some local land owners discussing potential trucked liquid waste solutions. Held a public hearing meeting regarding a past zoning issue and met with Chief Peters regarding possible solutions for the mining pit expansion.

<u>Director Davidson:</u> Noted that an incident occurred in Area F around an illegal dump site and looks forward to discussing this topic further at the upcoming Electoral Area Advocacy meeting. Open house taking place on April 23, 2025 for the development of the Hatzic Management Plan, hosted by Associated Engineering.

<u>Director Dickey:</u> Noted that the planning department held a public information meeting in Area D on a proposed large development in Popkum. The development is for approximately 265 units, and there were 100+ residents in attendance.
