# FRASER VALLEY REGIONAL DISTRICT BYLAW NO. 1787, 2025

#### A bylaw to amend the boundaries of the Parkview Street Lighting Service Area

**WHEREAS** the Fraser Valley Regional District Board of Directors ("the Board") has been petitioned to amend and extend the boundary of the Parkview Street Lighting Service Area established by Regional District of Fraser-Cheam Parkview Street Lighting Local Service Area Establishment Bylaw No. 1208, 1994;

**AND WHEREAS** BC Reg 113/2007 exempts service area boundary amendments from inspector approval where valid and sufficient petitions are submitted by the owners of the parcels to be added or removed;

**THEREFORE** the Board enacts as follows:

# 1) <u>CITATION</u>

This bylaw may be cited as *Fraser Valley Regional District Parkview Street Lighting Service Area Amendment Bylaw No. 1787, 2025.* 

# 2) <u>ENACTMENTS</u>

- a) Regional District of Fraser Cheam Parkview Street Lighting Service Area Establishment Bylaw No. 1208, 1994 is hereby amended by extending the boundaries of the Service Area to include the property shown on Schedule 1787-A attached to and forming an integral part of this bylaw.
- b) Schedule A to Bylaw No. 1208, 1994 is hereby replaced by Schedule 1787-B, attached to and forming an integral part of this bylaw. The amended boundaries of the service area shall be those portions of Electoral Area H as shown on Schedule 1787-B.
- c) That the provisions of all bylaws that are now in effect with regard to the establishment and amendment of the Parkview Street Lighting Service Area shall henceforth apply to those lands outlined on Schedule 1787-B of this bylaw.

# 3) <u>SEVERABILITY</u>

If a portion of this bylaw is found invalid by a court, it will be severed and the remainder of the bylaw will remain in effect.
