FRASER VALLEY REGIONAL DISTRICT BYLAW NO. 1792, 2025

A bylaw to amend the boundaries of the Electoral Area D Integrated Water System Service Area

WHEREAS the Fraser Valley Regional District Board of Directors ("the Board") has been petitioned to amend and extend the boundary of the Electoral Area D Integrated Water System Service Area established by Bylaw No. 0861, 2011;

AND WHEREAS BC Reg 113/2007 exempts service area boundary amendments from inspector approval where valid and sufficient petitions are submitted by the owners of the parcels to be added or removed;

THEREFORE the Board enacts as follows:

1) <u>CITATION</u>

This bylaw may be cited as *Fraser Valley Regional District Electoral Area D Integrated Water System Service Area Amendment Bylaw No. 1792, 2025.*

2) <u>ENACTMENTS</u>

- a) *Fraser Valley Regional District Electoral Area D Integrated Water System Service Area Merger Bylaw No. 0861, 2011* as amended, is hereby amended by extending the boundaries of the Service Area to include the property shown on Schedule 1792-A attached to and forming an integral part of this bylaw.
- b) Schedule A to Bylaw No. 0861, 2011 is hereby replaced by Schedule 1792-B, attached to and forming an integral part of this bylaw. The amended boundaries of the service area shall be those portions of Electoral Area D as shown on Schedule 1792-B.
- c) That the provisions of all bylaws that are now in effect with regard to the establishment and amendment of the Electoral Area D Integrated Water System Service Area shall henceforth apply to those lands outlined on Schedule 1792-B of this bylaw.

3) <u>SEVERABILITY</u>

If a portion of this bylaw is found invalid by a court, it will be severed and the remainder of the bylaw will remain in effect.
