FRASER VALLEY REGIONAL DISTRICT BYLAW NO. 1796, 2025

A bylaw to amend the boundaries of the Cultus Lake Integrated Water Supply and Distribution System Capital Construction Service Area

WHEREAS the Fraser Valley Regional District Board of Directors ("the Board") has been petitioned to amend and extend the boundary of the Cultus Lake Integrated Water Supply and Distribution System Capital Construction Service Area established by Fraser Valley Regional District Cultus Lake Integrated Water Supply and Distribution System Capital Construction Service Area Establishment Bylaw No. 1366, 2016;

AND WHEREAS BC Reg 113/2007 exempts service area boundary amendments from inspector approval where valid and sufficient petitions are submitted by the owners of the parcels to be added or removed:

THEREFORE the Board enacts as follows:

1) <u>CITATION</u>

This bylaw may be cited as *Fraser Valley Regional District Cultus Lake Integrated Water Supply and Distribution System Capital Construction Service Area Amendment Bylaw No. 1796, 2025.*

2) ENACTMENTS

- a) Fraser Valley Regional District Cultus Lake Integrated Water Supply and Distribution System Capital Construction Service Area Establishment Bylaw No. 1366, 2016, is hereby amended by extending the boundaries of the Service Area to include the property shown on Schedule 1796-A attached to and forming an integral part of this bylaw.
- b) Schedule A to Bylaw No. 1366, 2016 is hereby replaced by Schedule 1796-B, attached to and forming an integral part of this bylaw. The amended boundaries of the service area shall be those portions of Electoral Area H as shown on Schedule 1796-B.
- c) That the provisions of all bylaws that are now in effect with regard to the establishment and amendment of the Cultus Lake Integrated Water Supply and Distribution System Capital Construction Service Area shall henceforth apply to those lands outlined on Schedule 1796 B of this bylaw.

3) SEVERABILITY

If a portion of this bylaw is found invalid by a court, it will be severed and the remainder of the bylaw will remain in effect.




