## FRASER VALLEY REGIONAL DISTRICT BYLAW NO. 1801, 2025

## A bylaw to amend the Electoral Area Commercial Gravel Operations Service Area Establishment Bylaw No. 1409, 2018

WHEREAS the Fraser Valley Regional District Board of Directors ("the Board") wishes to amend the Fraser Valley Regional District Electoral Area Commercial Gravel Operations Service Area Establishment Bylaw No. 1409, 2018 to include the establishment of a regulatory service in relation to the deposit of soil and other materials generally within participating electoral areas;

**AND WHEREAS** consent on behalf of the electoral participating areas of the Fraser Valley Regional District has been obtained:

THEREFORE the Board enacts as follows:

#### 1) CITATION

This bylaw may be cited as Fraser Valley Regional District Electoral Area Commercial Gravel Operations and Soil Deposit Service Area Amendment Bylaw No. 1801, 2025.

## 2) <u>ENACTMENTS</u>

Fraser Valley Regional District Electoral Area Commercial Gravel Operations Service Area Establishment Bylaw No. 1409, 2018 is hereby amended by:

- a) adding the following after the first WHEREAS Clause:
  - "AND WHEREAS the Board also wishes to establish a service, in addition to a service for regulating commercial gravel operations, for more generally regulating the deposit of soil and other materials within the service area";
- b) changing the citation of the bylaw to "Fraser Valley Regional District Electoral Area Commercial Gravel Operations and Soil Deposit Establishment Bylaw No. 1409, 2018";
- c) deleting Section 2(a) in its entirety, and replacing it with the following:
  - "a) The Board hereby establishes the Electoral Area Commercial Gravel Operations and Soil Deposit Service Area in participating electoral areas for the following purposes:
    - i. to regulate aggregate operations, including aggregate removal and deposit, processing and other related activities, and
    - ii. to regulate and manage the deposit of soil and other material, and related activities."
