

FRASER VALLEY REGIONAL DISTRICT
BYLAW NO. 1811, 2025

A bylaw to amend the regulations, fees and other charges for the Vedder River Campground

WHEREAS the Board of Directors of the Fraser Valley Regional District (“the Board”) wishes to amend *Fraser Valley Regional District Vedder River Campground Regulations, Fees and Other Charges Bylaw No. 1476, 2018*.

THEREFORE the Board enacts as follows:

1) **CITATION**

This bylaw may be cited as the *Fraser Valley Regional District Vedder River Campground Regulations, Fees and Other Charges Amendment Bylaw No. 1811, 2025*.

2) **ENACTMENTS**

That *Fraser Valley Regional District Vedder River Campground Regulations, Fees and Other Charges Bylaw No. 1476, 2018* is amended by:

- a) Deleting the term “group Campsites” from the entirety of this bylaw.
- b) Replacing “large non-serviced Campsites” with “large Unserviced Campsites” for the entirety of this bylaw.
- c) Replacing “large partial hook-up Campsites with a shelter” with “large Campsite with picnic shelter and water” for the entirety of this bylaw.
- d) Replacing “regular non-serviced Campsites” with “tent Campsite” for the entirety of this bylaw.
- e) In Section 7.1, deleting the phrase “group Campsites and” in the first sentence.
- f) Deleting Section 7.3 in its entirety and replacing it with:

“Campers may amend their reservation to an alternative date within the same operating season, subject to fees and charges as per Schedule A of this bylaw. All reservation changes must comply with applicable terms and conditions and are contingent upon availability.”
- g) Deleting Section 8.1 in its entirety and replacing it with “There must be only one (1) Camping Party per Campsite.”
- h) Deleting Section 8.2 in its entirety and replacing it with:

“With the exception of large Unserviced Campsites and large site with picnic shelter and water, the maximum size of any Camping Party is eight (8) persons, no more than four (4)
