FBC Fraser Valley Update Fraser Valley Regional District Board of Directors October 2018

Following is a brief update of some of the work the Fraser Basin Council has completed or is undertaking in the Fraser Valley.

Lower Mainland Flood Management Strategy – LMFMS

- Orphan Dikes FBC is managing a project to assess more than 100 orphan dikes in B.C. that have no local authority responsible for operations and maintenance. The work includes field surveys of the dikes, assessing consequences of a dike failure, and preliminary design and cost estimates to upgrade dikes to provincial standards. This project will be of particular interest to local governments where these structures are located. - Seismic Vulnerability of Dikes Work continues on assessing seismic vulnerability of dikes and development of
 a seismic program. A workshop held June 18 with local governments reviewed the draft report by Golder, now
 completing this scoping study report. Meetings with provincial staff and with Sto:lo Research and Resource
 Management Centre (SRRMC) reviewed permitting processes for geotechnical investigations along dikes. A
 contract was signed with SRRMC to conduct a Cultural Heritage Overview Assessment (CHOA) of proposed
 borehole drill sites from Mission to Hope to identify archaeological and cultural heritage resources that could be
 impacted. An RFP will be out this fall to select a contractor to conduct permitted geotechnical investigations and
 seismic assessment of the dikes.
- The Environment Advisory Committee met on Sept. 10. The online Flood and Environment atlas is progressing
 well. A workshop and field tour held in Chilliwack on June 26 looked at flood management and the environment,
 including work at some First Nations communities. An overview of regulatory processes and related challenges
 and opportunities has been started.
